**RESOLUTION NUMBER 15-07**

**RESOLUTION ESTABLISHING A  
DEPOSITORY AND AUTHORIZING  
FINANCIAL TRANSACTIONS**

WHEREAS, GROVELAND COMMUNITY SERVICES DISTRICT (hereinafter the "District") is a community services district formed and operating pursuant to the provisions of California Government Code Section 61000 et seq., and is authorized to designate a financial institution of its choice to act as a depository for District funds; and


WHEREAS, District desires to designate Pacific State Bank, 18667 Main Street, Suite E, Groveland, California 95321, as the authorized depository of the District's funds and as the financial institution that the District will utilize for loans, lines of credit and other financial arrangements found necessary by the District to finance District facilities and operations; and

WHEREAS, the Board of Directors hereby finds that it is in the public interest and in the best interest of the District to designate Pacific State Bank as an authorized depository for District funds and a preferred financial institution with which to enter into agreements regarding the financing of District operations and facilities by means of loans, lines of credit and other similar financial arrangements.

NOW THEREFORE, BE IT RESOLVED by the Board of Directors of the District as follows:


RESOLVED, that Pacific State Bank at any one or more of its offices or branches, be and it hereby is designated as the financial institution of and depository for the funds of the District, which may be withdrawn on checks, drafts, advices of debit, notes or other orders for the payment of monies bearing the following appropriate number of signatures: any two (2) of the following named officers or employees of the District ("Agents") whose actual signatures are shown below:



and that Pacific State Bank shall be and is authorized to honor and pay the same whether or not they are payable to bearer or to the individual order of any agent or agents assigning the same.

RESOLVED FURTHER, that Pacific State Bank is hereby directed to accept and pay without further inquiry any item drawn against any of the District's accounts with Pacific State Bank bearing the signature or signatures of Agents, as authorized above or otherwise, even though drawn or endorsed to the order of any Agent signing or tendered by such Agent for cashing or in payment of the individual obligation of such Agent or for deposit to the Agent's personal account, and Pacific State Bank shall not be required or be under any obligation to inquire as to the circumstances of the issue or use of any item signed in accordance with the resolutions contained herein, or the application or disposition of such item or the proceeds of the item.

RESOLVED FURTHER, that any one of such Agents is authorized to endorse all checks, drafts, notes and other items payable to or owned by this District for deposit with Pacific State Bank, or for collection or discount by Pacific State Bank; and to accept drafts and other items payable at Pacific State Bank.

RESOLVED FURTHER, that the above named agents are authorized and empowered to execute such other agreements, including, but not limited to, special depository agreements and arrangements regarding the manner, conditions, or purposes for which funds, checks, or items of the District may be deposited, collected, or withdrawn and to perform such other acts as they deem reasonably necessary to carry out the provisions of these resolutions.

RESOLVED FURTHER, that the above named agents are authorized and empowered to execute such loan and credit agreements, including, but not limited to, promissory notes, security agreements, applications for lines of credit and other arrangements regarding the lending of credit to the District by Pacific State

Bank pursuant to resolution of the Board of Directors of District specifically authorizing such credit arrangements;

RESOLVED FURTHER, that the authority hereby conferred upon the above named Agents shall be and remain in full force and effect until written notice of the revocation thereof shall have been delivered to and received by Pacific State Bank at each location where an account is maintained. Any such notice shall not affect any items in process at the time notice is given.
