Bonds/Debt and Water + Sewer Rate Information

Bonds/Debt

The District has incurred debt (e.g. revenue bonds) to purchase, upgrade or replace capital improvements such as storage tanks, water and sewer lines, and treatment facilities. Debt is generally repaid on a semi-annual basis over a period of 20 to 30 years. The District collects monthly debt service fees to repay these bonds.

- **1996 Capital Facilities Bond**
This bond was sold for the acquisition, construction and improvement of water storage and treatment facilities, an upgrade that was necessary because of increased population and State Health Department standards. The bond was issued for \$4,500,000 and was paid off by the subsequent 1998 bond sale (see 1998 capital facilities bond below).
- **1998 Capital Facilities Refunding Revenue Bond**
This bond was issued to refinance the 1996 Capital Facilities Bond at a lower interest rate. The bond was issued for \$4,600,000 and will be paid off in March 2026. The monthly payment for this bond is \$9.83 and it is paid by all GCSD water customers.
- **2007 Water Debt Service (formerly called 2005-06 Capital Facilities Bond)**
This \$5,031,500 debt was incurred in May 2007 to pay for federal and state mandated upgrades to the two water treatment plants, construction of an emergency water supply system, and upgrade to the radio telemetry and control (SCADA) system. The District had been collecting \$5.13 toward this debt service charge. The monthly amount was increased to \$10.75 in May 2007. This debt service is paid by all GCSD customers.
- **2007 Wastewater Debt Service**
This \$4,059,000 debt was incurred in June 2007 to pay for state mandated upgrades to the District's sixteen sewer lift stations. The monthly debt service charge is \$25.75 and is paid by customers who are on the sewer systems tributary to Lift Station 7.

Water and Sewer Rates

- **Monthly Fixed Rate/Minimum Charge for Water and Sewer**
This charge provides for the fixed annual costs of operating the buildings, grounds and facilities of the District, irrespective of the quantity of water used or occupancy status.
- **Water and Sewer Consumption (Variable Rate) Charges for Water and Sewer**
This charge provides for the variable costs of operation and maintenance of the systems, directly proportional to the amount of water used.
