

## RESOLUTION 31-2025

### A RESOLUTION OF THE BOARD OF DIRECTORS OF THE GROVELAND COMMUNITY SERVICES DISTRICT APPOINTING ATTORNEY JOSH VARINSKY OF WHITE BRENNER LLP AS THE PRIMARY ATTORNEY PROVIDING GENERAL LEGAL COUNSEL FOR THE DISTRICT

**WHEREAS**, the Groveland Community Services District (“District”) requires legal counsel to support its operations and ensure compliance with federal, state, and local laws and regulations; and

**WHEREAS**, following a competitive Request for Proposals process, the District entered into a Professional Services Agreement with White Brenner LLP on June 29, 2023, for the provision of general legal counsel services; and

**WHEREAS**, the proposal submitted by White Brenner LLP identified Douglas White as the Primary Attorney and Josh Varinsky as the Secondary Attorney assigned to the District; and

**WHEREAS**, over the past two years, Attorney Josh Varinsky has provided consistent, responsive, and high-quality legal counsel to the District, effectively serving as the District’s primary legal contact and developing a strong working relationship with District staff and management; and

**WHEREAS**, Mr. Varinsky has demonstrated expertise in public agency law and has provided valuable support on matters including the Brown Act, public contracting, employment law, land use, LAFCO, and the resolution of unauthorized encroachments; and

**WHEREAS**, staff recommends that Mr. Varinsky be formally designated as the District’s Primary Attorney from White Brenner LLP to accurately reflect his current role and ensure continuity of legal services;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Directors of the Groveland Community Services District as follows:

1. The Board hereby designates Attorney Josh Varinsky of White Brenner LLP as the Primary Attorney providing general legal counsel services to the District under the existing Professional Services Agreement dated June 29, 2023.
2. All other terms and provisions of the existing agreement shall remain unchanged and in full force and effect.
3. This Resolution shall take effect immediately upon its adoption.
