

RESOLUTION NO. 9-07

**A RESOLUTION OF INTENTION TO LEVY ASSESSMENTS
FOR FISCAL YEAR 2007-08, PRELIMINARILY APPROVING
ENGINEER'S REPORT, AND PROVIDING FOR NOTICE OF HEARING
FOR THE GROVELAND COMMUNITY SERVICES DISTRICT**

WHEREAS, on July 8, 2002, by its Resolution No. 10-02, after receiving a weighted majority of 61% of ballots in support of the proposed assessment, this Board ordered the formation of and levied the first assessment of the Groveland Community Services District Fire and Rescue Assessment District (the "Assessment District") within the Groveland Community Services District (the "District") pursuant to the provisions of Article XIID of the California Constitution, and Government Code Sections 50078 et. Seq.; and

WHEREAS, Resolution No. 2-07 designated SCI Consulting Group as Engineer of Work for purposes of these proceedings and ordered SCI Consulting Group to prepare an Engineer's Report in accordance with the California Government Code Sections 50078 et. Seq. and Article XIID of the California Constitution; and

WHEREAS, SCI Consulting Group have filed with the Board of Directors of the Groveland Community Services District, a Preliminary Engineer's Report which contains: (a) a calculation of the portion of the services to be provided by the Assessment District that constitute a special benefit to the parcels in the District; (b) a methodology for assigning fire suppression assessments to individual parcels; (c) a listing of each lot or parcel of property that would be subject to the fire suppression assessment including public parcels; (d) the amount of the proposed assessment for each lot or parcel for the 2007-08 fiscal year; and (e) an assessment diagram depicting the boundary of the Assessment District.

NOW, THEREFORE, BE IT RESOLVED, by the Governing Board of the Groveland Community Services District, County of Tuolumne, State of California, that the Preliminary Engineer's Report is hereby received and filed; and

BE IT FURTHER RESOLVED, by the Governing Board of the Groveland Community Services District that it is the intention of this Board to levy and collect assessments within the Assessment District for fiscal year 2007-08.

BE IT FURTHER RESOLVED, by the Governing Board of the Groveland Community Services District that the authorized maximum assessment rate for the District includes an annual adjustment by an amount equal to the annual change in the San Francisco Bay Area Consumer Price Index, not to exceed 3% per year. As the amount of the annual increase in the San Francisco Bay Area Consumer Price Index from January 1, 2006 to January 1, 2007 is 3.441%, the authorized maximum adjustment for fiscal year 2007-08 is 3% above the maximum levy rate for fiscal year 2006-07. The

unused CPI change of 0.441% will be deferred and used for a future year when the yearly CPI change is less than the maximum of 3%. Including the authorized annual adjustment, the maximum authorized assessment rate for fiscal year 2007-08 is \$76.94 per single family equivalent benefit unit and the proposed fiscal year 2007-08 assessment rate per single family equivalent benefit unit is \$76.94.

BE IT FURTHER RESOLVED, by the Governing Board of the Groveland Community Services District that a Public Hearing regarding the continuation of the Assessment District shall be held on July 9, 2007 at 9:00 a.m. or as soon after as practical, at the Groveland Community Services District offices located at 18966 Ferretti Road, Groveland, California, 95321.




