

RESOLUTION 14-2026
A RESOLUTION OF THE BOARD OF DIRECTORS OF THE GROVELAND
COMMUNITY SERVICES DISTRICT AMENDING RESOLUTION NO. 20-2025 TO
EXTEND THE TIMELINE FOR DEVELOPMENT OF A MULTI-YEAR FIRE
SERVICES AGREEMENT

WHEREAS, the Groveland Community Services District (herein referred to as District) is a local government agency formed and operating in accordance with Section §61000 et seq. of the California Government Code; and

WHEREAS, on June 10, 2025, the Board of Directors adopted Resolution No. 20-2025 establishing a joint commitment with Tuolumne County to develop a long-term fire services agreement; and

WHEREAS, Resolution No. 20-2025 originally established a target timeline to complete such agreement prior to March 2026; and

WHEREAS, both agencies continue to evaluate long-term service delivery, operational, and financial considerations associated with fire protection services in the greater Groveland area; and

WHEREAS, the parties have extended the existing co-location agreement through June 30, 2027 to allow sufficient time for development of a comprehensive long-term agreement; and

WHEREAS, the Board desires to amend Resolution No. 20-2025 solely to extend the timeline for completion of the long-term agreement, without modifying any other provisions or commitments;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors of the Groveland Community Services District does hereby:

1. Amends Resolution No. 20-2025 to revise the timeline for development and approval of a long-term fire services agreement from March 2026 to June 30, 2027; and
2. Affirms that all other provisions, findings, and commitments contained in Resolution No. 20-2025 shall remain in full force and effect; and
3. Authorizes the Board President and Secretary to sign and attest to the adoption of the Amended Resolution 20-2025, on the Resolution No. 47-26 as adopted by Tuolumne County; and
4. Directs staff to continue working collaboratively with Tuolumne County toward development of a long-term fire services agreement consistent with the intent of Resolution No. 20-2025.




