**A RESOLUTION OF THE GROVELAND COMMUNITY SERVICES DISTRICT  
BOARD OF DIRECTORS APPROVING THE APPROVING THE THIRD  
AMENDMENT TO THE TUOLUMNE COUNTY FIRE SERVICES PROVIDERS  
AUTOMATIC AID/MUTUAL AID AGREEMENT TO INCLUDE CAL FIRE  
TUOLUMNE CALAVERAS UNIT**

**WHEREAS**, the Groveland Community Services District (herein referred to as District) is a local government agency formed and operating in accordance with Section §61000 et seq. of the California Government Code; and

**WHEREAS**, in 2016 the District along with 9 other agencies entered into an Automatic Aid/Mutual Aid Agreement with Tuolumne County Fire Service Providers; and

**WHEREAS**, in 2019 the agreement was amended to include the Tuolumne Band of Me-Wuk Indians as a signatory to the Automatic Aid/Mutual Aid Agreement; and

**WHEREAS**, in July 2025 the agreement was amended to include the Chicken Ranch Rancheria of Me-Wuk Indians as a signatory to the Automatic Aid/Mutual Aid Agreement; and

**WHEREAS**, the third amendment is proposed to add CAL FIRE Tuolumne Calaveras Unit as a signatory to the Automatic Aid/Mutual Aid Agreement; and

**WHEREAS**, all participating agencies must execute the Automatic Aid/Mutual Aid Agreement accepting the amendments.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Directors of Groveland Community Services District does hereby adopt Resolution 38-2025 approving the Third Amendment to the Tuolumne County Fire Services Providers Automatic Aid/Mutual Aid Agreement to Include CAL FIRE Tuolumne Calaveras Unit.
