A RESOLUTION OF THE GROVELAND COMMUNITY
SERVICES DISTRICT BOARD OF DIRECTORS
ADOPTING REVISIONS TO THE DISTRICT'S
PERSONNEL RULES AND REGULATIONS
DISTRICT HOLIDAYS

WHEREAS, the Groveland Community Services District and Operating Engineers, Local Union No. 3 have entered into a memorandum of Understanding for Fiscal Year 2000-2002 regarding the terms and conditions of employment for Maintenance, Operations, and Safety Union; and

WHEREAS, since the pendency of labor negotiations between Groveland Community Services District and Operating Engineers, Local Union No. 3, the employees in the Maintenance, Operations and Safety Unit no longer fell subject to the terms and conditions of employment set forth in Section VI of the GCS D Personnel Manual; and

NOW THEREFORE, BE IT RESOLVED, by the Board of Directors of the Groveland Community Services District that the following dates will be recognized as paid holidays for the Groveland Community Services District:

1. New Years Day - Monday, January 1, 2001
2. Martin Luther Kings Birthday - Monday, January 15, 2001
3. Presidents Day - Monday, February 19, 2001
4. Memorial Day - Monday, May 28, 2001
5. Independence Day - Wednesday, July 4, 2001
6. Labor Day - Monday, September 3, 2001
7. Thanksgiving Day - Thursday, November 22, 2001
8. Day after Thanksgiving - Friday, November 23, 2001
9. Christmas Eve - Monday, December 24, 2001
10. Christmas - Tuesday, December 25, 2001
11. New Years Day - Tuesday, January 1, 2002

In addition, employees not subject to the provisions of the Memorandum of Understanding between Groveland Community Services District and Operating Engineers Local 3 may take two (2) floating holidays which must be used during 2001 and cannot be carried over into next calendar year or cashed out.

BE IT FURTHER RESOLVED, by the Board of Directors of the


