

RESOLUTION 29-2026

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE GROVELAND COMMUNITY SERVICES DISTRICT ADOPTING THE 2025 URBAN WATER MANAGEMENT PLAN

WHEREAS, the Urban Water Management Planning Act (California Water Code Sections 10610 through 10656) requires every urban water supplier providing water for municipal purposes to more than 3,000 service connections or supplying more than 3,000 acre-feet of water annually to prepare and periodically update an UWMP (UWMP); and

WHEREAS, California Water Code Section 10621 requires urban water suppliers to review and update their UWMP every five years and submit the adopted Plan to the California Department of Water Resources (DWR); and

WHEREAS, the Groveland Community Services District (District) is an urban water supplier as defined by California Water Code Section 10617 and previously adopted its 2020 UWMP on November 9, 2021; and

WHEREAS, the District has the authority to construct, operate and maintain the water distribution system; and

WHEREAS, the Draft 2025 UWMP has been prepared in accordance with the requirements of the Urban Water Management Planning Act and the California Department of Water Resources 2025 UWMP Guidebook; and

WHEREAS, pursuant to California Water Code Sections 10621 and 10642, the District provided notice of its intent to prepare the 2025 UWMP to the applicable public agencies, made the Draft 2025 UWMP available for public inspection, published notice of the public hearing in accordance with Government Code Section 6066; and

WHEREAS, a duly noticed public hearing was held by the Board of Directors on September 9, 2026, during which all interested persons were given an opportunity to be heard and all comments received regarding the Draft 2025 UWMP were considered prior to adoption.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors of the Groveland Community Services District hereby approves the Groveland Community Services District's 2025 UWMP; and

BE IT FUTHER RESOLVED, that, the General Manager, or designee, is authorized and directed to submit the adopted 2025 UWMP to the California Department of Water Resources, the California State Library, and all other agencies as required by California Water Code Section 10644, to make the adopted Plan available for public review, and to take all actions necessary to implement the requirements of the Urban Water Management Planning Act.

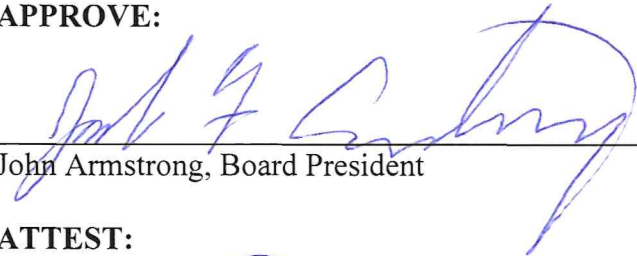

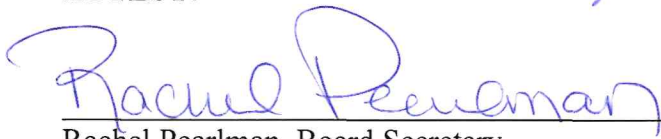
